Disclosures: ****Please Read Carefully****

- You will be asked to schedule your follow-up at the end of each visit. *We cannot stress enough how important these follow-up visits are to maintain progress of the treatment.*
- In approximately 7-10 days you *may* experience an exacerbation of your symptoms. This is referred to as a “healing crisis.” This is normal/expected, although it does not impact everyone. If you experience strong reactions, please contact the office. We will provide instructions necessary to minimize this normal response.
- Nutritional supplements (Sols) may contain alcohol. If you cannot use alcohol, please advise us.
- To achieve the best progress in your treatment, take the nutritional supplements (Sols) as directed.
- Please do NOT take your nutritional supplements (Sols) within 5 hours of the time you come for your follow up visit so as to not negatively impact the evaluation. We recommend that you make a note on your calendar to remember this time restriction on the day of your follow-up.
- You will be given one specialty blue light per household to enable you to easily determine the level of liquid remaining in your nutritional supplement (Sols) bottles. I understand that the light has the potential to cause injury if not utilized correctly, and I will take full responsibility to use the light properly (e.g.: not point the light in anyone’s eyes).

- If you would like our help to determine when to buy more nutritional supplements (Sols), please come prepared: use the blue light provided to you to determine the amount of sprays remaining in your current bottles; record this on the sheet provided to you. After your appointment, we will work with you to determine what nutritional supplements (Sols) you are recommended to purchase.
- Special orders and back-orders may be necessary; prepayment of these orders is required. We will contact you when your order has arrived for you to pick up the ordered item(s). Please keep in mind when ordering that it generally takes 7-14 days for us to receive shipments for backorders/special orders.
- To help us feel your pulse with more ease, drink plenty of water prior to your appointment.

- If you choose to take your nutritional supplements (Sols) with you while traveling by air, make every attempt to take nutritional supplements in your carry-on luggage. Please be aware that there is a risk of leakage and/or security check challenges. Occasional exposure to x-ray should not harm them. Also, do not expose the nutritional supplements (Sols) to extremes of temperature or leave them near strong electrical sources. Please do not hesitate to contact us if you have questions.
- *NO nutritional supplements (Sols) will be accepted for return.*
- I understand that no services or products offered by Feeling Better Together will be charged to my insurance company. I understand I will be financially obligated to pay the total amount in full at the time of service. We accept Visa, MC, Discover, American Express, Debit cards, and cash.
- Feeling Better Together is *By Appointment Only*. We will do our best to return phone calls or emails initiated by the client as soon as possible. NOTICE OF PRIVACY PROCEDURES

This notice describes how medical information about you may be used and disclosed and how you can get access to this information. Please review it carefully.

The Health Insurance Portability & Accountability Act of 1996 (HIPAA) requires all health care records and other individually identifiable health information (protected health information) used or disclosed to us in any form, whether electronically, on paper, or orally, be kept confidential. This federal law gives you, the patient, significant new rights to understand and control how your health information is used. HIPAA provides penalties for covered entities that misuse personal health information. As required by HIPAA, we have prepared this explanation of how we are required to maintain the privacy of your health information and how we may use and disclose your health information. Without specific written authorization, we are permitted to use and disclose your health care records for the purposes of treatment, payment and health care operations.

- **TREATMENT** means providing, coordinating, or managing health care and related services by one or more health care providers.
- **PAYMENT** means such activities as obtaining reimbursement for services, confirming coverage, billing or collection activities, and utilization review. An example of this would be billing your medical plan for your medical services.
- **HEALTH CARE OPERATIONS** include the business aspects of running our practice, such as conducting quality assessment and improvement activities, auditing functions, cost-management analysis and customer service. An example would include a periodic assessment of our documentation protocols, etc.

In addition, your confidential information may be used to remind you of an appointment (by phone or mail) or provide you with information about treatment options or other health-related services including release of information to friends and family members that are directly involved in your care or who assist in taking care of you. We will use and disclose your protected information when we are required to do so by federal, state or local law. We may disclose your protected health information to public health authorities that are authorized by law to collect information, to a health oversight agency for activities authorized by law included but not limited to: response to a court or administrative order, if you are involved in a lawsuit or similar proceeding, response to a discovery request, subpoena, or other lawful process by another party involved in the dispute, but only if we have made an effort to inform you for the request or to obtain an order protecting the information the party has requested. We will release your protected health information if requested by law enforcement officials for any circumstance required by law. We may release your protected health information to a medical examiner or coroner to identify a deceased individual or to identify the cause of death. If necessary, we also may release information in order for funeral directors to perform their jobs.

We may release protected health information to organizations that handle organ, eye or tissue procurement or transplantation, including organ donation banks, as necessary to facilitate organ or tissue donation and transplantation if you are an organ donor. We may use and disclose your protected health information when necessary to reduce or prevent a serious threat to your health and safety or the health and safety of another individual or the public. Under these circumstances, we will only make disclosures to a person or organization able to help prevent the threat. We may disclose your protected health information if you are a member of US or foreign military forces (including veterans) and if required by the appropriate authorities. We may disclose your protected health information to federal officials for intelligence and national security activities authorized by law. We may disclose protected health information to federal

officials in order to protect the President, other officials or foreign heads of state, or to conduct investigations. We may disclose your protected health information to correctional institutions or law enforcement officials if you are an Inmate or under the custody of a law enforcement official. Disclosure for these purposes would be necessary: (a) for the institution to provide health care services to you, (b) for the safety and security of the institution, and/or (c) to protect your health and safety or the health and safety of other individuals or the public. We may release your protected health information for workers compensation and similar programs.

Any other uses and disclosures will be made only with your written authorization.

You may revoke such authorization in writing and we are required to honor and abide by that written request, except to the extent that we have already taken actions relying on your authorization.

You have certain rights with regards to your protected health information, which you can exercise by presenting a written request to our privacy office at the practice address listed above.

- The right to request restrictions on certain uses and disclosures of protected health information, including those related to disclosures to family members, other relatives, close personal friends, or any other person identified by you. We are, however, not required to agree to a requested restriction. If we do agree to a restriction, we must abide by it unless you agree in writing to remove it.
- The right to request to receive confidential communications of protected health information from us by alternative means or at alternative locations.
- The right to access, inspect and copy your protected health information
- The right to request an amendment to your protected health information
- The right to receive an accounting of disclosures of protected health information outside of treatment, payment and health care operations.
- The right to obtain a paper copy of this notice from us upon request.

We are required by law to maintain the privacy of your protected health information and to provide you with notice of our legal duties and privacy practices with respect to protected health information. We are required to abide by the terms of the notice of privacy practices currently in effect. We reserve the right to change the terms of our Notice of Privacy Practices and to make the new notice provisions effective for all protected health information that we maintain. Revisions to our Notice of Privacy Practices will be posted on the effective date and you may request a written copy of the Revised Notice from this office. You have the right to file a formal, written complaint with us at the address above, or with the Department of Health & Human Services, Office of Civil Rights, in the event you feel your privacy rights have been violated. We will not retaliate against you for filing a complaint.

Instructions for Clients Using Spray and Pellet Nutritional Supplements (“Sols”)

Note: *If you have a known allergy to alcohol or a history of alcohol abuse/addiction, do NOT take Liquid Spray Sols since they are alcohol based. You must coordinate with the office to take the pellets nutritional supplements instead.*

1. Liquid Sprays: Spray the Sol directly into your mouth under your tongue. Try to let them sit under your tongue before swallowing.

Pellets: Place the Pellets under your tongue and let them dissolve. Do not chew them.
2. Both: If prescribed to take them more than once per day, **make sure to have at least 1 hour between doses.**
3. Both: **You can continue taking any traditional western or herbal medicines together with your Sols.** Because the Sols work by stimulating the body’s self-defense mechanism, there is no danger of interaction or incompatibility while taking other kinds of treatments at the same time. They work on different levels.
4. Both: **Please wait at least 10 minutes before and after eating or drinking to take your Sols.** It is advised to not drink coffee or eat chocolate 10 minutes before or after taking your Sols. Also, avoid eating mint or brushing your teeth with mint-flavored toothpaste for 10 minutes before or after taking your Sols.
5. Both: **Store all Sols away from any temperature fluctuations, direct light, or heat.** Do not leave them in your car. Do not store the Sols in the refrigerator or close to a heat source. Caffeine, chocolate, strong herbs, or perfumes may reduce the effectiveness of the Sols. Do not store your Sols near these substances.
